### 4. List of Deliverables:

Consultancy firm will have the responsibility to inspect the site condition and workout a complete plan for construction of the facilities.

The consultancy firm has to submit a complete Detailed Project Report (DPR) with approved drawings duly approved by the approval authority.

The DPR should have the following contents:

- (i) Complete Project Plan & Schedule for realization.
- Report on the Site Soil condition and other related Engineering parameters. (ii)
- (iii) Complete Building Design details and Engineering Drawings with floor plan. Layout of each building to be finalised in consultation with user.
- (iv) Layout plan of the site with Main Access roads for Entry & Exit, other roads connecting with in the facilities, Hard Stand for Parking etc. The roads should have street lights, drainage system, and ductable pipe and cable lines.
- Complete electrification plan including total power requirement, arrangement (v) for EB power, backup DG power, and schematic for distribution.
- (vi) Provision for Lightening protection, Earth pit etc.
- (vii) Complete plan for load handling equipment like EOT crane.
- (viii) Estimation of AC system for PEB requiring Air Conditioning.
- (ix) Plan for safely Infrastructure like fire Alarm system, Fire Fighting System, Fire hydrant system etc.
- Provision of Security Surveillance system. (x)
- Telephone facility for internal communication. (xi)
- Security and administration building adjacent to main entry and exit, Vehicle (xii)
- (xiii) Total project cost estimation including BOM breakups with costing.
- (xiv) Regular site visit during construction period.
- Consultancy during Execution of Project: The consultation firm should extend the consultancy & monitoring services all through the implementation and execution phase as per DPR.
- Delivery Period: Approved DPR to be submitted within 60 days from the date of 6. issue of PO at BrahMos Aerospace (BAPL), Hyderabad both signed Hard copy and Soft сору.

- Payment Terms: 50% payment against delivery & acceptance of DPR along with approved layouts, drawings and schematics. Remaining 50% payment during construction phase in 5 mutually agreed stages of project implementation as per DPR as follows:
  - a. 10 % payment on First Stage project completion and inspection report.
  - b. 10% payment on Second Stage project completion and inspection report.
  - c. 10% payment on Third Stage project completion and inspection report.
  - d. 10% payment on Forth Stage project completion and inspection report.
  - e. 10% payment on Final Stage project completion and inspection report.

#### 10. Requisites for Vendor to Participate in Tender:

- The firm has to be enlisted as infrastructure design service provider in defense establishments like DRDO.
- The firm has minimum 20 Years of experience in design and development of buildings/structures/ PEBs in the field of infrastructure.
- The firm should have work experience in Secret/ Strategic projects
- The firm should have executed Infra related projects continuously for past 5 years. (2 project completion certificate to be provided).
- The firm should have minimum 20 nos of talented technical personnel in current regular pay roll (Copy of Form-16 to be provided).
- The firm has average turnover of more than 03 Crore annual turnover in past 3 years (GST/IT return proof).
- Availability of Software with the firm for CAD, structural design & analysis with software skilled technical personnel.

Note: Check list with copy of documents as per Annexure-II to be provided along with Technical Bid.

- Liquidated Damages (LD): LD will be charged at the rate of 0.5% per week of delay or part thereof subject to a maximum of 10% of the order value of undelivered items, on failure of delivers the items as per the schedule (Subjected Force Majeure clause): LD waiver, if any for reasons beyond the control of vendor / not attributable to vendor, may submit with justification well in advance / prior to delivery of items / before generating the invoice by the vendor / expiry of delivery period for consideration of LD waiver by BAPL. LD once deducted, if any shall not be refunded in any case.
- 12. Cancellation of Agreement: The BrahMos shall without prejudice to any other right or remedy, which shall have accrued or shall accrue thereafter to cancel the agreement on the recommendations of Progress Review Committee (PRC) on mutually, agreed terms and the amount of payment to be jointly for adjustment as recommended by PRC.
- Force Majeure: Should any Force Majeure circumstances arise, each of the contracting party shall be excused for the non-fulfilment or for the delayed fulfilment of any of its contractual obligations, if the affected party within 30 (Thirty) days of its occurrence informs in writing to the other party.

Force Majeure shall mean fires, floods, natural disasters, epidemic or other acts, that are unanticipated or unforeseeable, and not brought out at the instance of the party claiming to be affected by such event, or which, if anticipated or foreseeable could not be avoided or Hydo abad. \* provided for and which has caused the non-performance or delay in performance.

- 14. <u>Disputes</u>: All disputes or differences arising out of or in connection with the present Contract including the ones connected with the validity of the present contract or any part thereof, shall be settled by bilateral discussions. Both, BrahMos Aerospace and Vendor, will make every effort to resolve the dispute if any, in a mutually acceptable manner.
- 15. <u>Termination</u>: BrahMos shall have the right to terminate the order in case the delivery of the material is delayed for causes not attributable to Force Majeure for more than 12 months after the scheduled date of delivery.
- 16. **Quote Validity:** Should of minimum 45 Days from the due date for submission of Quote.
- 17. <u>Due date extension</u>: In the event of frim requires more time for submitting the quote, the same is required to communicated in the above mentioned email before expiry of RFQ due date. Extension sough after due date may be considered as "regret to Quote"
- 18. Regret to submit Quotation: In case the vendor regrets to submit Quotation, the documents / CD in encrypted format provided along with RFQ are to be returned in as issued condition without any duplication and / or photocopying. In case of non-conformance, the supplier may not be considered in future tendering process.
- 19. <u>Other Terms</u>: The Quotation should clearly indicate Rate / Price per Unit, **HSN Code** (8 Digit), Rate of GST, Your GSTN, MSME Status, **Best Possible Lead Time**, **Warranty** etc. and other terms and conditions, if any also should be indicated.


