#### B. For Technical Position (TP) Equipment:

There are two categories of equipment which are to be covered under Comprehensive Maintenance:

<u>Category – I:</u> COTS Items including Material Handling Equipment, Test Gauges and Lifting and Mounting Systems, Electrical & Electronics Devices.

**Category** – **II:** Custom – Made Stationery and Mobile Material Handing Equipment which requires basic maintenance like Lubrication and Cleaning.

#### Note:

- (a) Being a comprehensive Maintenance, Consumables required for this equipment also needs to be provisioned by the suppliers who intend taking up this work package.
- (b) The Calibration of the devices (which are Electronics, Electrical and Mechanical Equipment also needs to be undertaken) as part of this package
- (c) The detailed list will be shared with the firms during the presentation.
- 2.0 **Procedure to be followed during the Award of Contract:** The firms interested in undertaking the above activities will need to follow the following steps:
  - (i) Send the Vendor Assessment Form to BAPL via e-mail
  - (ii) Based on the Vendor Assessment, BAPL will invite all the prospective bidders to BAPL, New Delhi for a meeting (Being a sensitive Defence Location, the exact details of equipment will be made available during the meeting and subsequent RFP).
  - (iii) Based on the Vendor Assessment by Company Officials, RFP will be issued to shortlisted firms.
  - (iv) Based on participation during the bid process (Two Stage: Techno Commercial Bids and Price Bids), firms quoting will be invited for Technical and Commercial Evaluation. The Techno Commercial Evaluation will be carried out on the basis of Quality Cum Cost Basis.
  - (v) Based on Technical and Commercial Evaluation, technically competent firms will be invited for Cost Negotiation Committee. The Price Bids will be opened in front of all the participating firms.
  - (vi) The exact location of providing services will be disclosed during the presentation at a suitable date as per the Company to the shortlisted parties for provision of these services
  - (vii) The Tender Document (RFP) will be uploaded on website after this process is complete for the sake of all participants. BrahMos Aerospace is free to invite more participants in case the response for this EoI is not sufficient. The interest shown for this EoI is not binding for not calling for more participation by the Company.
